

Trust Online Enhancements

The following are enhancements to Trust Online that took place on **Monday, September 8th**:

Reservation System:

DCPF has implemented a new Reservation System for claims on Trust Online. This system will reserve Draft claims for firms so the Facility would not be able to work on these claims until the firm decides to submit the claim.
