


Trust Online Enhancements – 4/7/08

There have been several updates to Trust Online that took place Sunday April 6, 2008. These updates include the following:

1. Firm Super Users are now able to restrict Staff and Attorney account users from viewing the Summary Statistics on the Summary screen. A new check box has been added to the User Accounts profiles. If this box is unchecked, the statistics will not be visible to the user.


